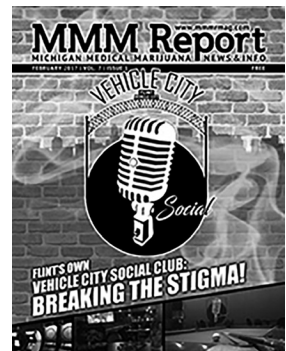
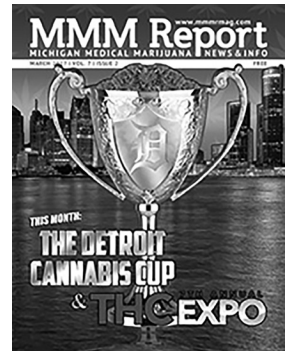

Full Page* - 8" x 10" (Finish size)

1/2 Page - 7" x 4.5"

1/4 Page - 3.5" x 4.5"

*Full page ads require an 1/8" bleed be added to all sides, and a minimum 1/2" margin to ensure important information is not cut off in production. Keep in mind that camera-ready or "flat" images cannot be edited or updated by our design team.

COMPANY LOGOS:

If possible, the advertiser should supply a brand identity graphic to the magazine via email. If you do not have a logo, we can produce one for use in the ad.
